Nominations should be kept confidential and must be signed by at least two individuals (nominators are not required to be Members of CPA Nova Scotia). Nominators must submit a letter explaining why they have nominated the Member and should include additional material such as letters of commendation, news articles highlighting the nominee’s activities and achievements and other appropriate information.

CPA Nova Scotia may undertake efforts to validate any information contained herein by contacting nominators or outside sources, while acting in accordance with our privacy policy.

Nominators are responsible for ensuring that the information provided is accurate and sufficient to allow the Member Recognition Committee to fairly evaluate the nomination. A nominator should clearly describe the groups, committees, individuals, and organizations in which the Member has been involved, any significant volunteer accomplishments as well as the relevant dates for each.
